WHEREAS, Education Code 17605 provides that the Governing Board of the School District, by a majority vote, may adopt a rule delegating to any officer or employee of the district as the board may designate, the authority to purchase supplies, materials, apparatus, equipment and services; and

WHEREAS, Education Code 17605 further provides that this authority is limited to purchases equal to or less than the amount specified by Section 20111 of the Public Contract Code;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the San Diego Unified School District of San Diego County, California, that the following named officers or employees of the District, and each of them, are authorized to purchase supplies, materials, apparatus, equipment, and services on behalf of this board:

- Chief Business Officer
- Executive Director, Facilities
- Director, Facilities Planning and Construction
- Director, Physical Plant Operations
- Director, Business Support Services

BE IT FURTHER RESOLVED that the aforementioned officers or employees of the District, and each of them are authorized to sign contracts, leases, or other documents for the purchase of supplies, materials, apparatus, and equipment, and services, in amounts equal to or less than the amount specified by Section 20111 of the Public Contract Code, and said contracts, leases, or other documents shall subsequently be reviewed by this board every sixty (60) days.

BE IT FURTHER RESOLVED that the aforementioned officers or employees of the District, and each of them, are authorized to sign purchase orders, contracts, leases, or other documents for the purchase of supplies, materials, apparatus, equipment, and services in amounts greater than the amounts specified in Section 20111 of the Public Contract Code which have been approved in advance by the Board of Education.
