**How do the teachers at your site balance cognitive learning and affective learning for their GATE students?**

Instruction and grouping are based on assessment. Students participate in Second Step lessons for discussion on behavior and emotional concerns. Counselor also available to meet with students.

**What support does your site provide for GATE students who are underachieving, learning the English language, at-risk, and/or double-labeled?**

We have an extra teacher to pull low performing students in grades 4 and 5. Aides are also assigned to classes with lower performing students. Students are paired with other students that speak the same language.

**How does your site involve your DAC representative and/or your GATE steering committee in planning and reviewing your site's GATE program?**

Last year we had a GATE Task Force which included Doyle staff and parents determine out GATE Program. They reported their findings to the Governance Team and SSC> They changed our Model A Program from 100% GATE [enrollment] to 75% GATE [enrollment] with high achievers.

We divide the total amount of funds by the number of GATE students. This year we gave each GATE teacher \$45 per GATE student.

GATE funds are used to enrich instructional materials or for extra assemblies and field trips. The principal reviews and approves all purchases.
